

# Regulations/Conditions

## **48th "Four Days of the Yser"**

In 2020 the Four Days of the Yser will take place for the 48th time from Tuesday 18 to Friday 21 August. The Four Days of the Yser is a non-competitive walk with the challenge to walk a daily route of 8, 16, 24 or 32 km for 4 days.

## **Regulations**

### **Article 1**

**The Four Days of the Yser is organized by the non-profit organization Four Days of the Yser (Vierdaagse van de IJzer vzw).**

### **Article 2**

**The Four Days of the Yser is a walking tour and not a competition. Participation is voluntary and at one's own risk.**

### **Article 3**

**Registration takes place in accordance with the conditions determined by the non-profit organization Four Days of the Yser. Registration is strictly personal and cannot be transferred.**

### **Article 4**

**During the event participants are, in any manner whatsoever, prohibited to**

- **express a political or religious persuasion**
- **carry advertising material, except with the consent of the executive committee**
- **carry weapons, whether or not visible, except by servicemen**
- **make use of a means of transport**
- **carry radios or other sound media playing loudly**
- **carry or bring along objects that can endanger other participants**
- **make use of handcycles or other chain-driven wheelchairs (only ordinary wheelchairs are allowed for disabled participants)**

### **Article 5**

**The participants, our staff and the public cannot in any way express a political or religious preference during the event.**

### **Article 6**

**Participants are obliged to follow the signposted walking routes and carry their walking card visibly.**

### **Article 7**

**Participants are required to dress in accordance with public decency standards.**

## **Article 8**

**Instructions from the organization, the police and other staff shall be observed and respected. The traffic regulations apply on public roads.**

## **Article 9**

**Violations of these regulations may result in the immediate exclusion from participation, in following editions as well, without any compensation or reimbursement.**

## **Article 10**

**Four Days of the Iron accepts online payments with BANCONTACT, MAESTRO, VISA and MASTERCARD. If you choose to pay by credit card, the amount will be debited from your card immediately upon confirmation of payment. Any paid registration fee cannot be refunded by the organizer under any circumstances.**

## **Article 11**

**By registering for the Four Days of the Yser the participant declares that he is familiar with and agrees with the regulations.**

## **Article 12**

**By registering the participant agrees to the use of his personal details and/or his image in print, on photo, film, video and the like by the non-profit organization Four Days of the Yser for promotional or informing purposes, without the participant being entitled to any compensation.**

## **Article 13**

**The non-profit organization Four Days of the Yser cannot in any way be held responsible or liable (to pay compensation) for any accident and/or illness of participants, for any loss of property, or for any other alleged damage suffered by a participant.**

## **Article 14**

**The organizer reserves the right to change the routes, the starting and arrival times or the starting and arrival places, or to cancel the Four Days of the Yser fully or partly because of extreme weather conditions or other circumstances determined by the organizer, with or without consultation with the authorities or the police. In those cases participants are not entitled to a refund of the registration fee or to compensation of any damage whatsoever.**

## **Article 15**

**In all cases not covered by these regulations the executive committee of the non-profit organization Four Days of the Yser is authorized to take a decision. In case of disputes about the interpretation of these regulations only the Dutch text shall prevail. All lawsuits shall be settled by the court of Veurne.**
